MONETA distributed CZK 6.2 million to non-profit organizations through the MONETA Clementia Foundation

Prague, 12 January 2024

In the second round of the grant programme to support the socially vulnerable, children, the elderly and environmental protection, MONETA distributed CZK 6.2 million through the MONETA Clementia Foundation. A total of CZK 7.3 million was distributed to 78 non-profit organisations in 2023 under both grant rounds.

In the second round of the grant programme, MONETA, through the MONETA Clementia Foundation, distributed more than CZK 6.2 million among 58 non-profit organisations. It supported, for example, the Alsa association, which brings together patients and professionals interested in amyotrophic lateral sclerosis, the Achilles patient organisation for the purchase of special medical equipment and webinars for parents of children with "club foot", or the opening of a new centre for victims of domestic and sexual violence forFem.

A unique condition for the acceptance of a grant application is the assumption of patronage by a MONETA Money Bank employee. *"Employees choose the organisation for which they submit a project to the grant programme. This creates a link between personal values and the mission of the MONETA Clementia Foundation,"* says Zuzana Filipová, a member of the Board of Directors of the MONETA Clementia Foundation and Director of Sustainability and Communication of the MONETA Group. A total of 116 organisations with 118 projects applied for financial support during October. The applications were voted on by members of the MONETA Clementia Foundation Board of Directors.

The grant programme has been announced by MONETA since 1996. Since autumn 2023, it has been financed by the MONETA Clementia Foundation, which was originally established to help clients who have fallen into a difficult life situation and are unable to meet their obligations to MONETA Group companies. Last year, it expanded its scope to include financial support for children from children's homes, non-profit organisations and bank's employees who find themselves in a difficult life situation.
