# MONETA offers a new accident insurance with a double benefit limit

Prague, 24 January 2024

**MONETA provides up to CZK 800,000 per claim in the event of traffic accidents or injuries to children during the announced school holidays and subsequent weekends under a new form of accident insurance. This has been offered since the end of last year in cooperation with the BNP Paribas Cardif insurance company.**

The insurance covers the risk of accidents worldwide, and provides cover for multiple injuries such as stitches, fractures or burns within a single accident. *"We provide double benefit in the event of a road traffic accident in cooperation with our partner insurance company, regardless of the age of the insured or the package they have chosen as part of their accident policy. In the case of double benefit for accidents to children during school holidays, this financial bonus is then paid under the Junior or Family package. However, these model situations are no longer multiplied: if, for example, a child is injured in a car accident during the spring holidays, the benefit is doubled only once,"* explained Zuzana Filipová, spokesperson for the MONETA Group, adding that a collision with a pedestrian or a rider on a bicycle, scooter or tricycle is also considered a traffic accident.

Insurance can be arranged either in person at any bank branch, by phone at the call centre or online via the Smart Banka mobile banking application. In addition to accident insurance, the package also includes additional insurance for accompanying a child in hospital after an accident or for treating a family member after an accident. In addition, as a benefit, the insurance company covers a lump sum of CZK 1,000 for the purchase of medical aids, payment of the emergency room fee or parking in front of the hospital for most claims.
